

# **Roger Taylor Selected as** District Governor 2021-2022



In accordance with the District 7450 Bylaws and the proceedings of the District Nomination Committee the District Governor for 2021-2022 will be Mr. Roger Taylor of the Coatesville Rotary Club. He is now the District Governor Nominee Designate. On July 1, 2019, he will become the District Governor Nominee. On July 1, 2020 he will become the District Governor Elect.

Roger has been a member of the Rotary Club of Coatesville since 2014 where he held several positions, including club president, and has perfect attendance since 2015. He has brought four new members into the club In District

Administration he served on the District Membership Committee, Chair of the Four Way Test Competition, an Assistant District Governor, and the faculty of the Rotary Leadership Institute. His official Rotary designation is astronomy.

Now retired, Roger keeps busy with hobbies that include archery, cooking, kayaking, photography and gardening. Most of all, Roger is an astronomer. Over the years he built his own Newtonian telescopes; the largest is 14 inches in diameter. He has served with organizations including the Chester Astronomical Society, Delaware Valley Armature Astronomers and wrote "Starstuff", a syndicated column for ten years. Those who know him are not surprised that Roger is a member of the Concordia Coral Arts. His baritone voice is highly sought after by many.

# Gundaker Foundation Repositions for the Future

Gundaker Foundation chair Bill Graham and the executive committee proposed a new course forward for the Foundation. It was enthusiastically approved by the directors at the November meeting and action to implement it is under way. The Foundation will reposition its work to being in line with Rotary International's Areas of Focus and effect stronger community service. This revision is still being studied and clarified before changes are made to the bylaws.

Also under development are plans to improve communications to the clubs in District 7450. The executive committee is scheduling club visits, creating literature and generating information periodically to keep club members well informed.

### Three Areas of Focus

Gundaker will concentrate on three primary areas of focus that are taken from Rotary International's six areas of focus.

Those areas will be:

- Education and Literacy
- Promoting Peace and Conflict Resolution
- Mother's and Children's Health

Grant requests presented to the foundation should encompass one or more of those three areas. Gundaker directors should use these areas of focus to guide them on whether a proposed project is worthy of a grant from the foundation.

### <u>Club Grants</u>

### (Formerly National and International Grants)

The National and International Grants will be rolled into one committee called Club Grants. These will follow a similar application process and National and International Grants have in the past.



International Grants will only be considered if a current, active club member (cannot be honorary) is traveling with and working on the proposed project.

Along with these changes, Gundaker is raising the matching grant to \$1,000 per project.

### Vocational and Technical Grants

Vocational and Technical Grants will take the place of Under Graduate and Graduate Grants. Gundaker will issue 5 grants per year. To qualify for a grant, the applicant must be admitted to a 2 -year vocational or technical program at an accredited school, live in or going to school in District 7450 and have a minimum GPA of 3.0 or equivalent school ranking. The applicants must be going into their 2<sup>nd</sup> year of their 2-year program.

### Youth Exchange Program

Youth Exchange will continue to operate as it does today.

# District Publicity Committee Launches New Initiative

The newly-formed Publicity Committee, headed by Chuck Martz and AG Renee DeCoskey, comprises ten volunteers whose mission is to work with clubs on an individual basis, training members on the use of social media to publicize their clubs.

Beginning in January, committee volunteers will contact club presidents to arrange training sessions at mutually convenient times and places. They will be visiting clubs and speaking on the importance of establishing a social presence. The volunteers will remain as the clubs' social media mentors as club members negotiate through the platforms and develop their skills.

"Social media is the single best way for a club to inform the public about what they are doing for their community," says DeCoskey. "Whether it's reporting on a recent service project or getting the word out about an upcoming fundraiser, social media allows clubs to establish and extend their presence in the community. More than that, social media is one of the best ways for Rotarians to share with their friends, families, and networks about the good things Rotary does and how fun and rewarding it is to be a member."



## Things We Heard...

## **Turn-Around Scholarships**

Several Rotary clubs in Wisconsin offer a unique scholarship to late bloomers. These are high school students who "screwed up" in their freshman and sophomore years and need a second chance. "Students who simply made a mess of their first two years believe they don't have an opportunity to catch up, so they give up and never make the effort in junior and senior years," says guidance counselor Cristina Retay. "And, they're right. Schools rarely have programs to help them find their real potential. That's where Rotary steps in."

The clubs contact these students and offer them a deal few can refuse. The teens sign a contract that requires them to maintain excellent attendance, carry a B average, exhibit zero behavior problems, participate in after school activities and communicate regularly with the Rotarians.

In return, Rotary offers them support that includes tutoring,



mentoring and providing role models of caring adults. Rotarians work with guidance counselors to contact colleges and attest to how the students turned their lives around in junior and senior years. The Rotarians send positive letters to college entrance officials and include letters of recommendation from teachers and administrators. And, of course, these students are the first in line for Rotary financial scholarships. "The results have been inspiring. Our teachers are happy to see the changes and younger students are encouraged by their achievements." Reports Ms. Retay. "It's a great service to the students and the community."

## Nominating Committee

Nominating someone to the position of District Governor is the responsibility of the District Nominating Committee. The process is dictated by our Bylaws. (See Bylaws on the District Website: <u>Rotarydistrict7450.org</u>) It's a meticulously detailed process, but here it is in a nutshell:



The District Governor selects a committee consisting of five people who serve for the year:

- Chair:
  - A past district governor Douglas Blazey (Wayne)
- Committee:
  - A past district governor Ed Olsavicky (WEGO)
  - A past club president from Super Area 1 Dr. Gina Genin (Levittown-Fairless Hills) Dr. Geni participated by conference call.
  - A past club president from Super Area 2 Norman Viss (Broomall)
  - A past club president from Super Area 3 Marybeth Scott (Exton-Frazer/Great Valley)

The Committee Chair notifies all district Rotarians of the requirements for the position of District Governor in 2021-2022 and sets a due date to apply.

The Committee Chair arranges interviews with candidates and the Committee. Upon selection of the nominee, the Chair notifies all candidates and the District Governor of its decision.

The District Governor informs the district membership and sets a deadline of fourteen days in which time candidates who were not selected may challenge the Committee's decision. If challenged, there is a procedure for remedy set by Rotary International. If there is no challenge, the governor declares the chosen applicant as District Governor-nominee Delegate. The person will be the District Governor for 2021-2022.

Club, a person new to the area arrived. He said he was considering joining Rotary and sat in on the meeting. When the meeting ended he asked where he could sign up and did so on the spot.
