Dakota Meyer: An Inspiration!

Our keynote speaker was Dakota Meyer, recipient of the Medal of Honor. He talked about his life growing up in rural Kentucky, being recruited in high school by a Marine sergeant who said he wouldn't make it, and his tour of duty as a sniper in team of five military specialists training and fighting alongside Afghan soldiers.

Sergeant Meyer told about the battle of Ganjgal in 2009 when he disobeyed orders and drove into the killing field four times to rescue ambushed comrades under fire. He described the battle and his own hand to hand combat with a Taliban fighter. Sergeant Meyer also related finding the bodies of his four fellow marines and the guilt of not being with them in battle; it was the worst day of his life. He later suffered from PTSD and traveled the long road to recovery.



Sergeant Meyer concluded his address by telling the audience how he received a call from the White House staff saying he would receive a call from President Obama who would invite him to a medal ceremony. It went something like this:

Dakota: When will he call? White House: At such and such time tomorrow. Dakota: Well, that won't work. I've got a big job and can't walk away. Can he call me later when I'm off? White House: No. He will be traveling at that time. Dakota: Doesn't he have a cell phone or something?

They did settle on a time when the President would call, and he did. President Obama asked if there was anything he could do for him. "Well. I'd like to have a beer with you.", he said. So, they did. In the White House Rose Garden.

Afterwards, Sergeant Meyer took questions from the audience on a range of subjects. He talked at length about his life and philosophy. "You cannot let one day define you." He said. "Just as that day in Afghanistan does not define me." A life that has meaning begins with why you have firm beliefs. Then, that reason determines what you do in a life that matters. "You must have something that means more to you than all else, and you center all things around it." To Sergeant Meyer, it is his two young daughters. They are the center of his life.

Editor's note: We met with Dakota before the meeting and found a modest young man with a quick sense of humor. We asked if he knew anything about Rotary. "Sure." He said. "It's America's best kept secret."



Summary of Proposed Amendments

To Rotary International District 7450, Inc. (D7450) Bylaws

The clubs in District 7450 approved the incorporation of the district by email ballot in 2010. Incorporation means that we have a board of directors comprised of 4 members of the Governor line and 3 members representing our clubs. The corporation is governed by bylaws describing the responsibilities and the board and the corporate Members. Each club is called a "Member" of the corporation. Members must approve changes to the bylaws by approving amendments proposed by the District Bylaws and Legislation Committee (Committee).

The Committee has been meeting to review the existing bylaws with a goal of updating and simplifying them. The committee has prepared a draft of 3 amendments for each Member to approve by email ballot.

The **first amendment** is to change the method to elect At-large Directors of the Board from a direct election by the clubs to the same method used to select the governor. That method is to authorize the District Nominating Committee to ask clubs to nominate candidates for the position, to interview the nominees, to select the best qualified nominee, to announce the selection of the nominee to the clubs and to allow the clubs 14 days to challenge that selection. If there is a no challenge, the nominee assumes the position of At-large Director on July 1 of the next Rotary year.

The **second amendment** is to separate the current bylaws into two sections. **Section 1** would be called the Bylaws of Rotary International District 7450, Inc. That section would describe only the <u>corporate</u> functions of the board of directors. **Section 2** would be called Rotary District 7450 Guidelines. That section would describe only <u>district</u> related functions as prescribed by Rotary International. Those functions include a description of the organizational structure of the district itself and a description of district responsibilities of the district officers and district committees.

Any district Rotarian can propose an amendment to the Guidelines to the Committee. The Committee review proposed amendments. Then the Committee would recommend amendments to the Board for their approval. This expedited approval would enable the district to incorporate continuing changes enacted by the Council of Legislation to the Rotary International Bylaws and Constitution and other changes that should not rise to the level of a vote of the clubs.

The **third amendment** is to add policies to a new appendix section setting standards for: youth protection, harassment, district funds remuneration for committees and district and Rotary International events and a social media protocol.

The current bylaws are posted on the district website and the final draft amended version and a description of the proposed amendments will be posted shortly. Each Member (club) will receive a ballot to vote on each amendment and return that ballot via email to the Committee to finalize the amendment process.
