Living the 'Vida Loca' in District 4160

So, what happens when you put five American women, a ton of luggage, several cameras and a desire to explore a different culture, careers and Rotary in a plane headed to Mexico? You get the recent District 7450 GSE trip to Central Mexico.

This past April, I was lucky enough to lead a GSE trip to District 4160 that began in Morelia, Mexico. The story really begins when I gave my classification talk shortly after my induction into Rotary in 2005. I am a Spanish teacher at a local Montessori School and work exclusively with kindergarteners. The Glen Riddle Club President was listening and when the request came for a Spanish-speaking group leader, he challenged me and I accepted. The moral of the story:"Watch what you share at your Rotary meeting!" (Just kidding!)

Non-Rotarian, young professionals were selected as team members in early 2006: Jenée, a journalist; Juana, a social worker; Kathy, a professional photographer / commercial cleaning business owner; and Leah, a bilingual human resources assistant now studying for her teaching degree in ESL.

We visited four Mexican states and slept in 9 or 10 different beds. Various schools, rehab centers, newspaper and radio stations opened their doors to us so that we could learn about our careers as they are practiced in Mexico. We met the mayors of several towns and explored the history of Mexico, since we were in their Cradle of Liberty. (How appropriate for a team based in Philadelphia area!) We attended 15 Rotary meetings and the District Conference. The only thing we didn't do was sleep! We accomplished this most hectic schedule in 28 days.

We assisted in the collection of funds for the Red Cross in the small town of Lagos de Moreno. How odd, when you think about it! Five American women begging for funds in a foreign country in a different language and enjoying it! Guess what?The club doubled its normal "take" that day! Various radio and newspaper interviews had us feeling like celebrities, but the public relations

component of the interviews really brought the good works of Rotary to light. We translated a fellow California Rotarian's words when he donated goods for various projects in town. In turn, Louis Sciarrotta taught us what "Service above Self" really means.

We met a dying club in central Mexico that has only six remaining members. It was quite fulfilling to be able to provide the contact information for their next three District Governors, whom we had previously met! We are still brain-storming ideas to help this club get back on its feet.

We visited orphanages and senior centers that the local Rotary Clubs help with. We visited a town that lost two blocks of housing to a fire because the fire truck is inoperable. We learned that the needs are great throughout this section of Mexico and that the local Rotarians have learned how to help out with quite limited manpower and financial resources.

We learned a lot about ourselves as well. Spending four weeks traveling together in close quarters, speaking a foreign language, meeting new people daily, having little or no known schedule, dealing with technical presentation problems and being "put on the spot" by radio show hosts helped us all grow as individuals. The professional visits gave us ample opportunity to compare and contrast our jobs and skills and bring home new ideas for our employers. The Rotary experience just furthered our needs and desires to make our world a better place.

Most importantly, however, were the friendships we made. We met our brother Rotarians and instantly felt a bond to each and every one of them. The most difficult part of our journey was leaving a town, whether we had been there for a day or six days; the goodbyes were the hardest. Maybe that's why they say "hasta pronto," or see you soon, in Mexico instead of good-bye. (Continued on Page 2)

7450 Rotarians Answer Call from Katrina Victims

The recent flooding in our own area brings to mind the wonderful response from Rotarians in our District, to the devastating effects of Hurricane Katrina. It's hard to believe that it's been nearly a year since the devastation to the Gulf Coast. We need to be mindful that the reconstruction of that area is ongoing and will be for some time.

Thanks to the donation of \$58,000 by Rotarians, District 7450 was able to make a significant positive impact in three areas: Biloxi, and Bay St. Louis, Mississippi. and Pass Christian, Louisana. The funds were collected by Gundaker Foundation and distributed to specific projects.

Specifically, we were able to work through the Rotary Club of Media to help rebuild the library in Pass Christian. The library serves all the people of Harrison County and our money was specifically targeted for replacement of computer network equipment.

In Bay St. Louis, we worked through the local Rotary Club to aid Notre Dame de la Mer, which provides housing to the elderly in their area. Their entire first floor was destroyed and our contribution went toward helping to rebuild that portion of their property.

Finally, thanks to a contact made by Charlie Huntington, husband of Chesterbrook Rotarian Joann Huntington, we were able to help several institutions in Biloxi. Ellie Vasilopoulos of the Rotary Club of Biloxi was the key person "on the ground" to help us get to the institutions that would have the greatest positive impact in that community.

We were able to fund the Back Bay Mission, which serves 10,000 of the poorest of the poor along the Gulf Coast. That money was used primarily for a phone system and computers. Another beneficiary was Moore Community House, which provides early childhood services to approximately 180 families. Our money helped with utilities, classroom supplies, and equipment for an interim site. Wesley Academy was granted funding for tuition for six underprivileged students whose parents lost everything. The funds will be used for equipment and supplies. The Loaves & Fishes has fed the hungry of Harrison County for 20 years and we helped them to start over by helping with purchase of appliances and restoration. Ocean Springs-Long Beach Interfaith Hospitality Network provides emergency and transitional shelter and assistance to homeless families with children. The money was to help with office and industrial laundry equipment.

With the donations of local Rotarians, the Gundaker Foundation was able to make a difference in the lives of people in desperate need. If confronted with a disaster of this type again, we hope to have the same outpouring of generosity.

Twin Valley Rotary Club, Gundaker Fund Horsepower Motor to Deliver Water

Indiana, Peru on the Amazon River is a town of 4,000 mostly poor residents – farmers, fishermen, and artisans. It is accessible only by water. Indiana is a 45-minute boat ride down the river from Iquitos.

A potable water distribution system had been installed; however, the community did not have a motor or pump to supply water from the Amazon River to homes. The Rotary Club of Twin Valley and the Rotary Club Lima Sunrise joined to purchase a 60-horsepower diesel motor and centrifugal pump in Lima and to transport them across the Andes Mountains to Indiana.

Since the Amazon River has a tidal

rise and fall of 8 meters between rainy and dry seasons, the pump must be moved as the depth and width of the river changes. Therefore, the pumping station is mounted on a raft.

The location of the shoreline changes by 300 meters between seasons. As the water recedes during the dry season, residents use the exposed riverbed to cultivate rice until the river reclaims the land during the rainy season.

The Rotary Club of Twin Valley contributed \$5,000 and received matching grants from the Rotary Foundation and the Gundaker Foundation to meet the project cost of \$15,000. The Rotary Club of Lima Sunrise provided local coordination.

Rotary Foundation Enters New Era

When the Rotary Foundation was founded over a half a century ago, its long - term ambitions were focused on community service matching grants and building an endowment fund. Larger global programs such as Polio Plus, Health, Hunger and Humanities Grants, Rotary World Peace Scholars and Group Study Exchanges (GSE), took decades to develop as funds became available through significant membership growth.

The difference between now and Rotary's first Century of Service is that Rotary International is now interconnected with far-flung communities in 170 countries in efficient ways via the tools of the Information Age and the Internet. The Polio Eradication Effort has taught Rotarians that the once seemingly impossible is possible through our interconnected Rotary clubs and volunteers.

Larger capacity has challenged Rotarians to think globally and strategically in ways never before imagined. Our strength as an organization still rests with the vitality and commitment of each Rotary Club – large and small. Our 'strength' flows from our collective commitment of our time, our talents and our treasure (donations). It is the unique funding structure of our Rotary Foundation that prescribes that each club pledge every year what funds they hope to donate that Rotary Year. Each President-Elect has been asked to submit his or her 2006-2007 Fund Development Club Goal Report Form.

Each year's donations are held under prudent and sophisticated fiduciary care for a period of three years before they are released into two funds under the SHARE program. Thus 50% goes back into the account of the district that raised those funds (called District Designated Funds or DDF) and 50% goes into the World Fund which sustains long-range programs such as the Ambassadorial Scholars and GSE programs. The interest earned from this three-year stewardship goes towards administrative costs of the Rotary Foundation. Over \$86 million dollars are dispersed annually into Rotary Foundation Programs. So 100% of your donations go to Rotary service programs.

The managers of this crucial effort are chairpersons for the Rotary Foundation Committee in each Rotary Club. They are the vanguard who inspire, persuade and educate us in the good works of our Rotary Foundation. It belongs to us since we as clubs are its members and sustainers.

The trustees of the Rotary Foundation plan strategically based upon this three-year funding cycle and the annual pledge commitments of each Rotary Club. That is why these pledges are encouraged to be submitted before July 1st of each new Rotary Year. The reality is that each President-Elect often needs to wait until his/her term begins in order to make this pledge possible. I am asking each Club Foundation Chairperson to complete this pledge with the President and Board of Directors as soon as possible. The form was given to each President-Elect in the President's Manual at PETS. One copy is sent to the Rotary Foundation, one to your District Governor and the third copy is for the Club Foundation Chair and/or your club records.

The magnificent web of Rotary's willingness to accomplish great works really does hinge on the bedrock of each Rotary Club's pledge and ultimate donations. Please recognize and honor the unique role each Club Foundation Chair carries in this global quest to promote the success of Rotary's World Fund programs and its support of all the 530 Rotary Districts around the world today.

It is truly a new era of possibilities. . Let's make great things happen together!

Rotary Leadership Institute Plans Fall Schedule

The Rotary Leadership Institute (RLI) Home division, which conducts classes from Washington D.C. and north up the east coast including Canada, announces its schedule of fall 2006 classes. All Rotarians are invited to participate.

The RLI was started by Dave Linett, Past Rotary International Director, (PRID) from New Jersey, who believed that while the Presidents-Elect had training, other members, especially future club leaders, should also have the opportunity for training. The original program consisted of three sessions, from 8 a.m. until 4:30 p.m., usually but not always on a Saturday in the fall or spring. The sessions have been shortened to end at 3:30 p.m.. and there is a session for graduates of the previous sessions.

Each day-long session, which includes books and two meals, costs \$90 except for sessions scheduled at universities, which cost \$65. People, who are not pre-registered, are charged an extra \$10.

Last year, District 7450 had its highest participation rate ever with 65 people attending a class. This year we expect to have over 100 attendees with those who attended last year attending the second or third course and new people attending Course I.

While all Rotarians are welcome to attend, the courses are designed to train future club leaders. Since this is important to the club, clubs are urged to reimburse members who register and attend the full session. Every club President will be sent a package including brochures, instructions, and certificates to present to your future leaders recognizing their value to your club. Every club is urged to send two to four people to a session this fall.

Philadelphia Rotarians **Collect Books for Family Court**

In the spring of 2005, the Rotary Club of Philadelphia was approached by Judge Field of the Family Court of Philadelphia for help for a project she envisioned. Most of the cases brought before Judge Field involved young children and their parents who had to wait, sometimes for hours, in a stark, sparsely furnished waiting room.

The judge wanted to provide books for the young people so they had something to help occupy their time. Sadly, she had no budget for collecting new and slightly used books, so she turned to the Rotary Club for help.

Members of the Rotary Club of Philadelphia set about collecting new and used books, parts of family collections, and receiving donations from public libraries with overstocked books, and placing donation boxes at their places of business.

By the end of 2005, the club had delivered over 1000 children's books to the Family Court of Philadelphia. A second drive is underway to replenish books which were given to many of the children served by the court in an attempt to encourage reading at home.
