Westtown-Goshen Rotarians co-sponsor Health Advocacy Program in India

Community Health Advocacy Program, known as CHAP, was launched in Kochi, Kerala State, India October 14. CHAP is an international Matching Grant project jointly undertaken by the Westtown-Goshen Rotary Club, Westtown, PA USA (the international partner) and the Rotary Club of Fort Cochin, Kochi, India (the host partner). CHAP is a four-year pilot program to develop a prototype model and to provide health care to economically disadvantaged, orphans, elderly and the disabled in Kochi, India. Dr. Govinda Malya, immediate past president of Westtown-Goshen Rotary Club, is project director.

The program entails screening, treatment, follow-up visits and health education for diabetes, asthma and hypertension using a mobile van to deliver the health care services to people who would not have access to the services because they live in remote areas, lack transporta-

tion and do not have health care facilities near by.

The mobile van has been equipped with basic medical equipments and the services have been provided to the needy by health care professionals, volunteer Rotarians and people in the community. At the end of the 4-year duration of the project a "prototype" will be built that can be easily expanded to provide these services to remote areas in other countries such as Kenya, Peru, etc.

The program will have the long-term benefit of helping a society to better the peoples' health and educate them about their health to improve their quality of life.

Initially two screenings were completed of 106 patients who were provided health checks, free medicines and health education about diabetes, asthma and hypertension.

Gates Foundation: \$100 M to fight polio

Rotary International has announced a partnership with the Bill and Melinda Gates Foundation that will inject a much-needed \$200 million into the global campaign to eradicate polio, a crippling and sometimes fatal disease that still paralyzes children in parts of Africa, Asia, and the Middle East and threatens children everywhere.

The Rotary Foundation has received a \$100-million Gates Foundation grant, which Rotary has pledged to match, dollar-for-dollar, over three years.

Rotary will spend the initial \$100 million within one year in direct support of immunization activities carried out by the Global Polio Eradication Initiative, a partnership spearheaded by the World Health Organization (WHO), Rotary International, the U.S. Centers for Disease Control and Prevention, and UNICEF. "The extraordinary dedication of Rotary members has played a critical role in bringing polio to the brink of eradication," says Bill Gates, co-chair of the Bill and Melinda Gates Foundation. "Eradicating polio will be one of the most significant public health accomplishments in history, and we are committed to helping reach that goal."

The polio eradication grant is one of the largest challenge grants ever given by the Gates Foundation and the largest grant received by Rotary in its 102-year history. Polio eradication has been Rotary's top priority since 1985. Since then, Rotary has contributed \$633 million to the eradication effort. "Rotary members worldwide have worked very hard over the years to reach this point, and it is rewarding to see our approach validated in such a significant way by the Bill and Melinda Gates Foundation," says Dr. Robert Scott, who leads Rotary's polio eradication effort and chairs The Rotary Foundation.

Rotary International President Wilfrid J. Wilkinson adds, "This endorsement of Rotary's polio eradication efforts by the Bill and Melinda Gates Foundation is just the catalyst and challenge Rotary members need to keep our promise to the children of the world that polio will be eradicated."

Although the number of polio cases has been slashed by 99 percent over the past two decades, the wild poliovirus still persists in four countries: Afghanistan, India, Nigeria and Pakistan. These cases are the most costly to prevent due to geographic isolation, worker fatigue, low coverage with the vaccine, armed conflict, and cultural barriers.

Last month, WHO released data confirming that all four remaining polio-endemic countries are on track to achieve eradication. Significant progress has been made in India and Nigeria, which account for 85 percent of the world's polio cases. Nigeria has reported 226 cases this year, compared with 958 at the same time last year. In both countries, more effective oral polio vaccines have contributed to steady progress in reducing polio cases.

Most of the initial \$100 million will fund mass immunization campaigns in polio-affected countries, poliovirus surveillance activities, community education and outreach, and expanded research agenda on ways to halt the spread of the poliovirus. Rotary will distribute the funds through WHO and UNICEF.

"The funds made possible through the Gates Foundation grant will help the Global Polio Eradication Initiative scale up its efforts to provide oral polio vaccine to children in those isolated locations where it's most needed," says UNICEF Executive Director Ann M. Veneman.

Several members spent Saturday, October 20 enhancing the appearance of the Meade School by painting and collecting trash in and around the school.

U.S. Military helps in distribution of ShelterBoxes in Bangladesh after cyclone

Many survivors of the cyclone that hit Bangladesh last month have benefitted by the delivery of ShelterBoxes by the 22nd US Marine Expeditionary Unit. Many Rotary Clubs around the world support the ShelterBox program which provides accommodation and other survival essentials to disaster areas around the world.



Many families were living in makeshift shelters on the edges of roads and other patches of dry ground before the ShelterBoxes were delivered. The aid operation has been led by the country's military. Bangladesh supplies a large proportion of the UN's peacekeeping forces and its soldiers are experienced at working in very difficult situations but the aftermath of the cyclone stretched the nation's military to the limit and the United States Department of Defense responded to the Bangladesh's government request for assistance. That response is part of a larger United States response coordinated by the U.S. Department of State and the U.S. Agency for International Development. Until the Marines arrived, the ShelterBox Response Team was having difficulties getting its disaster ShelterBox out of Dhaka to the cyclone-stricken area because of blocked roads,

Six Bucks County Rotary Clubs fund two ShelterBox units to help victims of disasters

Six Rotary Clubs in Lower Bucks County, PA (Bensalem, Bristol, Feasterville, Langhorne, Levittown-Fairless Hills, and Shady Brook) joined together to provide direct relief for victims of disasters with immediate shelter and life-saving supplies.

ShelterBox USA is a grassroots Rotary Club project, which has helped thousands of homeless and refugees in more than 30 countries.

The ShelterBox mission is to deliver immediate relief to victims of natural and other disasters in any country. ShelterBox reaches those people most in need, through the network provided by Rotary International, and its 33,000 clubs worldwide.

Each Shelter/Box contains a rugged 10-person tent to be used as emergency accommodation and other survival essentials required by people who are suddenly homeless.

Each Shelter/Box can be delivered for about \$1,000. ShelterBox USA has sent aid to 31 different countries, providing shelter for more than 500,000 people in need.

RI lists tax changes for Rotary Clubs in 2008

Beginning in 2008, USA and Puerto Rican Rotary clubs and districts with gross receipts of \$25,000 or less will be required to file Form 990-N, an electronic e-Postcard report. This report is required annually starting 15 November 2008.

Failure to meet the annual filing requirement for three

consecutive years will result in revocation of the tax-exempt status of the club or district in question.

Rotary International indicates it wants to stress that this form is not required for submission until 2008.

Clubs are being alerted so that adequate receipts may be kept throughout the course of

the year. As of the date of this message, Form 990-N had not yet been posted on the US Treasury Web site.
